SECOND SUPPLEMENT TO DECLARATION OF COVENANTS AND RESTRICTIONS OF FLETCHER VALLEY

This Second Supplement to the Declaration of Covenants and Restrictions of Fletcher Valley ("Second Supplement") is made this <u>3</u> day of June, 2022, by PotlatchDeltic Real Estate, LLC, successor by name change of Deltic Real Estate, LLC, successor to Deltic Timber Corporation (the "Developer" or the "Declarant").

WHEREAS, Developer caused to filed in the office of the Circuit Clerk and Ex-Officio Recorder of Pulaski County, Arkansas, that certain Declaration of Covenants and Restrictions of Fletcher Valley on November 19, 2020, as Instrument No. 2020077705" (the "Covenant of Restrictions") creating a community known as "Fletcher Valley,"
